That the YUFA Undergraduate Scholarship value be raised to \$4,500, subject to the university's continuation of its practice of contributing to scholarships based only on merit (without financial need), where necessary.

Rationale:

The YUFA Undergraduate Scholarships and Bursaries Endowment was established with an endowment of \$2.4 million which has grown to \$4.3 million over time. Bursaries are needs based and the amount distributed for them has been increased over time. The amount for merit-based scholarships has remained the same since the last adjustment in the value of our 16 scholarships from \$3,000 to \$3,500 in 2007. The proposed increase to \$4,500 approximately compensates for inflation since that time and restores the approximately equal balance between bursaries and scholarships.

The university's contributions result in an increase in the portion of the endowment available for bursaries.

5. Directors' motion #2

That there shall be a cap of \$10,000 on the total amount of scholarship funding a recipient of a YUFA Scholarship can hold in each academic year.

Rationale:

There is currently no cap on the amount students can accumulate in an academic year by combining scholarships. Any resulting reduction in scholarship disbursements will increase the portion of the endowment available for bursaries.

6. Directors' motion #3

That the accumulated, undisbursed funds in the Transition Year Program Bursary account as of April 30, 2021 be disbursed by Student Financial Services as bursaries for students in the most need, including international students.

Rationale:

The pausing of the Transition Year Program has caused a \$58,000 accumulation in the amount available for disbursement from our TYP endowment. This can enable immediate distribution of 38 bursaries of \$1,500 which will have a significant impact for the beneficiaries. Many bursary endowments restrict distributions to Canadian citizens or those with Ontario resident status. Our TYP fund does not have this restriction so we will be able to particularly assist international students.
